**NORTHLAND UNDER 21 STROKEPLAY CHAMPIONSHIP 2012**

**CONDITIONS OF ENTRY**

1. **The Rules** are those of the **Royal and Ancient Golf Club of St Andrews** and the **Bay of Islands Golf Club Kerikeri local Rules** as posted.
2. All rounds are gross, played off the Blue tees for boys, yellow tees for girls, and playing conditions are **“Play the Lie”**, unless otherwise notified.
3. **Starting times** Rule 6-3(a): The player shall start at the time laid down. Competitors must be prepared to play any round when called upon to do so, and any round may be cancelled, postponed or modified by the Committee, at their discretion.
4. Any **dispute** or **protest** must be lodged in writing with the Committee within fifteen minutes of the completion of the Round in which the dispute occurs.
5. The Committee will decide all disputes, and be responsible for all matters pertaining to matches. Its decision on these matters will be final.
6. Players must be financial members of a Golf Club affiliated to the NZGA, and have a current Handicap Index. Junior Age group members submitting Entry must declare their age. Acceptance of Entry is at the discretion of the Tournament Committee.
7. Entries (with Entry fees) must be received by the **Club Manager by Wednesday 15 February, 2012.**
8. **Pace of Play:** Rule 6-7 will be strictly enforced. Each group must maintain its position on the course with respect to the group preceding them. Any group with a clear hole in front of them will be considered out of position. Penalties will be issued to teams in each group who by their pace contribute to such delay.  
Maximum time for completion of any stroke, including strokes on the putting green is:  
**For first player—50 seconds, Second and subsequent players—35 seconds.**  
Timing will commence when it is the player’s turn to play and the way ahead is clear.  
Players who do not comply with the Pace of Play guidelines as defined above will be penalised in accordance with Rule 6-7, further defined under Rule 32.
9. The field is limited to the first 96 paid entries.
10. A **PRELIMINARY DRAW** will be published in the Club’s website [www.bayofislandsgolf.co.nz](http://www.bayofislandsgolf.co.nz) on 17February 2012. No refunds will be made for withdrawal after the Draw is completed.
