GOLF NORTHLAND JUNIOR GIRLS SELECTION POLICY 2015

ELIGIBILITY:

1. Players must be a NZ Citizen or hold a NZ Residence Permit.
2. Players must be a member of a club within the Northland District.
3. Junior Players must be Under 19 years of age at the time of individual events or Under 21 in the case of the Junior Girls Interprovincial.
4. Players wishing to be considered for the 2015 Representative season should complete the form on page 4 and return it to Golf Northland.

THE NORTHLAND JUNIOR GIRLS SELECTION POLICY:

1. Performance at designated trial tournaments:

A cumulative scoring average across the designated trials will be used to judge player performance. Selectors will use a ranking list of both nett and gross performance at designated trial tournaments to help determine team selection. A current list will be kept on the Golf Northland website.

- a) Where representative matches involve the use of handicap the nett scoring list will be used to select the team. Where the event does not use handicap gross scores will be used to select the team.
- b) Selectors Picks: The final two (2) spots in any six (6) or eight (8) person team shall be the selector's picks. The selectors reserve the right to select any player as a member of any representative team.

2. Selection of the team and subsequent playing order is subject to the following criteria:

- a) Current handicap, form and general fitness
- b) Handicaps throughout the year
- c) Experience and availability
- d) Matchplay results in open events
- e) Game management skills, (includes course and self-management skills)
- f) Ability to contribute and function within the team environment
- g) Commitment and attitude
- h) Adherence to the rules of golf, Golf Northland code of conduct, and general good sportsmanship
- i) Junior Girls – where all other things are equal, places in the team will be awarded to those players who are members of the Golf Northland Academy

3. Players are expected to attend all compulsory trials.

Any request for dispensation must be directed, preferably in writing by email to the convenor of selectors Sherrill Glenn: glens@orcon.net.nz. Dispensation will only be granted in the following circumstances:

- A player is representing NZ, or attending an event as directed by NZ Golf
- A player is attending another significant provincial tournament
- A medical problem for which a medical certificate is produced
- A significant family event

Please also note:

- Prospective representative players must be eligible to represent NZ

Code of Conduct:

ALL Northland representatives are required to sign the Golf Northland players Code of Conduct on an annual basis. Failure to do so will result in non-selection.
